Below is some helpful information for opening a Trading Account with Kaan's Catering Supplies.

#### **Payment Terms**

• Payment Terms are Weekly, payment is due the first Monday following invoice.

#### **Invoices, Credit Memos & Statements**

- Invoices are delivered with your order.
- Copies of all invoice and credits are emailed to you on the day they are raised.
- Statements and Credit memos are emailed to you weekly, on a Monday.

#### **Payment of your Accounts**

- All new accounts require a direct debit form to be completed.
- You are welcome to pay your account before the direct debit is due. The direct debit will only debit your account if there is a balance that is due.
- If there is a reason why the direct debit amount should be not be taken, please advise the Accounts Office, at least 36 hours before the payment is due to be debited.

#### **Direct Debit Payment**

• We can take a direct debit from either a bank account or a credit card (visa and mastercard only).

#### Authorisation to open the account

- If your Account is to be opened in the name of a Company, then the application must be signed by at least one of the Directors of the Company.
- If you are a Sole Trader, then at least 1 owner must sign the application form.
- Identification such as Passport or Drivers Licence is required if the account is not being open in the name of a Limited Company.
- We suggest if you do not understand our Terms and Conditions that you seek Legal advice before signing the Application Form.

#### What happens once the account application has been sent to Kaan's

- Once your account has been opened, we will send you an email with more information including contact details of your Kaan's Representative.
- Your Kaan's Representative will contact you with regard to product and pricing information.

I may ask my bank to reverse a direct debit up to 120 calendar days after the debit if:

The initiator is required to give you a written notice of the amount and date of each direct debit no less than 10 calendar days before the date of the debit.

If the bank dishonours a direct debit but the initiator sends the direct debit again within 5 business days of the dishonour, the initiator is not required to give you a second notice of the amount and date of the direct debit.

- "Kaan's Group" means Kaan's Catering Supplies Limited and its related companies as defined in the Companies Act 1993 and their directors, officers, employees and agents. "Kaan's" means the Kaan's Group company with which the Client has or seeks to have a trading relationship, its successors and assigns or any person acting on its behalf or with its 1 1
- authority.

  "Client" means the person, company or entity (and if more than one, each of them jointly and severally) described as such on the invoices, application for credit, quotation, work authorisation, Online Ordering registration, Order or any other forms to which the Terms of Trade apply, plus its successors and assigns and includes any person using the Client's
- Login.
  "Goods" means Goods supplied by Kaan's to the Client (and where the context so permits shall include any supply of services) and are as described on the invoices, quotation, work authorisation, Order or any other forms as provided by Kaan's to the Client.
  "Contract" means any contract between the Client and Kaan's incorporating the Terms of
- Trade (without limitation, any application for credit provided by the Client to Kaan's, quotations or work authorisations).

ORDERING AND PAYMENT

- ORDERING AND PAYMENT
  By placing an Order, including by use of Kaan's Online Ordering, the Client represents that the Client has read, understood and accepted these Terms of Trade and agrees to be bound by them. Any Order placed constitutes a legal offer to purchase that is capable of being accepted by Kaan's regardless of whether or not the Client receives a confirmation of Order.
- The Client is liable for every Order made on its time client receives a commitment of orders. The Client is liable for every Order made on its behalf, whether using its Login or otherwise. Online Orders may be submitted at any time but will be deemed not received until Kaan's is
- next open for business. Business hours may vary with public holidays and other special circumstances
- The Client is responsible for keeping its Login details secure and confidential at all times Kaan's will use reasonable endeavours to ensure that information about Goods provided on
- Kaan's Online Ordering or otherwise is up to date and free from error but shall not be responsible for the accuracy or completeness of information provided by suppliers. Information about allergens is provided by suppliers and is a guideline only. The Client is responsible for checking Goods labels for detailed information.
- Goods offered for Ordering are subject to availability while stocks last. Kaan's may change information about Goods at any time, without notice. If Kaan's cannot supply the Goods ordered by a Client, Kaan's may either substitute similar Goods at its discretion or decline to fill the Order. If Kaan's supplies substitute Goods, any resulting price adjustment will be made to the total Price for all Goods included in the accepted Order, on the invoice for the Goods that are in fact supplied.

  Orders are accepted when the Goods are dispatched for delivery.

  Prices for Goods are the Prices displayed at the time the Order is submitted except:
- - in the case of manifest error; or any other error Kaan's notifies to the Client at any time; or
  - Goods that need to be weighed (e.g. fruit, vegetables, meat, cheese), for which the invoiced Price will be the actual weight of the Goods supplied at the applicable Price

  The Client may download or print information on Kaan's Online Ordering for its purchase records or personal use. Otherwise, no information on Kaan's Online Ordering may be copied, altered, transmitted or redistributed without Kaan's prior written consent
- At Kaan's sole discretion the Price shall be either:

  (a) as stated on Kaan's invoice for the Goods supplied; or
- (b) Kaan's current price at the date of delivery of the Goods.

  All Offer Prices are stated exclusive of GST, unless expressly stated otherwise. GST on

  Time for payment for the Goods is of the essence and shall be paid at Kaan's sole election:

- Notwithstanding risk in the Goods passing in accordance with clause 3.2, title in the Goods shall not pass to the Client until Kaan's has received in full (in cash or cleared funds) all sums due to Kaan's in respect of:

    (b) all other sums which are or which become due to Kaan's from the Client on any account
- Receipt by Kaan's of any form of payment other than cash shall not be deemed to be payment until that form of payment has been honoured, cleared or recognised and until then Kaan's ownership or rights in respect of the Goods shall continue.

- The Client shall inspect the Goods on delivery and shall within twenty-four (24) hours of delivery notify Kaan's of any alleged defect, shortage in quantity, damage or failure to ocmply with the description or quote energ, shortage in quantity, damage or failure to comply with the description or quote and supply the date and number of any invoice relating to the Goods. The Client shall afford Kaan's an opportunity to inspect the Goods within a reasonable time following delivery if the Client believes the Goods are defective in any way. If the Client shall fail to comply with these provisions the Goods shall be presumed to be free
- from any defect or damage.

  For defective Goods, which Kaan's has agreed in writing that the Client is entitled to reject.
  - Kaan's liability is limited to replacing the Goods provided that:
    (a) the Client has complied with the provisions of clause 5.1; and
  - (b) the Goods have been stored appropriately and/or used for their intended purpose; and (c) the Goods are returned in the condition in which they were delivered; and

- Kaan's warrants that Goods supplied to the Client shall meet all safety regulations and standards as defined by the Food Act 1981 and are eminently suitable for public

  All other guarantees, warranties and representations in relation to the Goods or their supply (including those contained in the Sale of Goods Act 1908) are excluded except to the extent that Kaan's cannot lawfully exclude them.
- The Client warrants that the Goods are not purchased for use primarily for personal, domestic or household purposes.
- SECURITY
- Capitalised terms in this clause 7 shall, as applicable, have the meaning given in the Personal Property Securities Act 1999 ("PPSA") and section references refer to sections of
- the PPSA.

  The Client grants a Security Interest to Kaan's in the Goods and all proceeds of the Goods and acknowledges that this agreement creates a Purchase Money Security Interest in the Goods and the proceeds of the Goods. The Client will, if Kaan's requests, sign any documents, provide all necessary information and do anything else required by Kaan's to ensure the Purchase Money Security Interest is a Perfected Security Interest. In addition to the Security Interest granted under clause 7.2 the Client also grants a Security Interest and After Acquired Property as security for all property as a securit
- Interest in all of the Client's Present and After Acquired Property as security for all moneys now and in the future owing by the Client to Kaan's under the Terms of Trade.
- The client's credit account may go in and out of credit over time. The Client acknowledges and agrees that the security interest granted to Kaan's shall not terminate upon the client's credit account balance returning to zero. Any subsequent credit granted to the client after the account has returned to zero shall be covered by the original security interest and shall retain the disciplination.

  Kaan's may register the above Security Interests at any time on the Personal Property Securities Register ("PPSR")

  The Client waives any right to receive from Kaan's a copy of any Financing Statement, Financing Change Statement or Verification Statement arising in connection with any registration made on the PPSR by Kaan's in connection with any Security Interest created by the Terms of Trade by the Terms of Trade.

  The Client undertakes to give Kaan's at least fourteen (14) days' notice of any change in the Client's name, address, electronic contact details and/or any other change in the Client's

  Should Kaan's elect to proceed in any manner in accordance with this clause and/or its subclauses, the Client shall indemnify Kaan's from and against all costs and disbursements
  incurred including any administrative or legal costs (on a solicitor / client basis) incurred in
  registering, maintaining, changing, discharging or enforcing any security interest.
- The Client agrees to irrevocably nominate constitute and appoint Kaan's or Kaan's nominee as the Client's true and lawful attorney to perform all necessary acts to give effect to the provisions of this clause 7.

PAYMENT DEFAULT

- Notwithstanding any other provision herein if the Client fails to make any payment on the Due Date then (without prejudice to any of Kaan's other rights and remedies) Kaan's may:
  - make immediate formal demand for all monies due and payable to Kaan's on any account whatsoever which monies shall then immediately fall due and become
  - payable; charge the Client administration fees and interest at the rate of half a per cent (1/2%) (b) per week which shall accrue on a daily basis on the total amount outstanding (including any costs of enforcement) from the Due Date to the date of payment in full and such interest shall be compounded weekly on the Monday of each week commencing the Monday following the Due Date on which the default was made; (c)

pass on to Kaan's appointed agent for the purposes of debt recovery any information Kaan's may hold regarding the Client or the Client's dealings with Kaan's;

CONSUMER GUARANTEES ACT 1993

When the Client purchases Goods for business purposes, the guarantees in the Consumer Guarantees Act 1993 are excluded.

LIMITATION OF LIABILITY

- Kaan's shall be under no liability whatever to the Client for any indirect or consequential loss and/or expense (including loss of profit or goodwill) suffered by the Client or any third party arising out of a breach by Kaan's of the Terms of Trade.

  In the event of any breach of this agreement by Kaan's the remedies of the Client shall be
- limited to damages, and Kaan's liability (if any) whether in contract, tort or otherwise in respect of any defect in the Goods, or for any breach of the Terms of Trade, or of any duty owed to the Client in connection with them shall be limited to the amount of the Price.

  10.3 Kaan's shall be excused from performance of any obligation under any Contract if it is
- unable to perform the obligation because of an event beyond its reasonable control including (without limitation) unavailability of Goods, law changes or other government acts, natural disasters, strikes or other shortages of labour, utility failures and transport delays

(b) disclosing information about the Client:

- to any person who guarantees or who provides insurance or who provides any other credit support in relation to the Client's obligations to Kaan's;
- to such persons as may be necessary or desirable to enable Kaan's to exercise any power, enforcement or attempted enforcement of Kaan's rights, remedies and powers under the Terms of Trade;

marketing goods and services; and

(d) transferring such information to any nominee or assignee of Kaan's.

The Client may access and update certain personal information held by Kaan's in the "My Account" area of Kaan's Online Ordering.

- 11.3 Personal information entered using the Client's Login will be encrypted before transmission over the internet and stored on a secure server. Kaan's will use reasonable endeavours to prevent unauthorised access to Kaan's Online Ordering but no member of Kaan's Group shall be liable for any loss resulting from unauthorised access to Kaan's Online Ordering
- except where a member of Kaan's Group has acted maliciously or fraudulently.

  Kaan's Online Order may use 'cookies' which are elements of data the web site can send to your browser which may then be stored on your system. To use Kaan's Online Ordering, you do not necessarily need to enable your browser to accept cookies. Some information or services may not be available if you disable cookies.

NOTICES

NOTICES

All notices shall be in writing and, unless otherwise required by law, shall be deemed to have been served if delivered in person or posted, or sent by any electronic method (including text message, email and other electronic messaging platforms) to the contact details provided by the Client to Kaan's for the purposes of receiving notices. It is the Client's responsibility to advise Kaan's of any changes to such details.

The Client will pay Kaan's on demand all costs (including debt collection costs and legal costs on a solicitor/client basis) incurred by Kaan's in connection with the enforcement or attempted enforcement of Kaan's rights, remedies and powers under the Terms of Trade.

- If Kaan's delays or does not exercise any of Kaan's rights or remedies under the Terms of
- Trade or otherwise at law, that will not be a waiver of the right or remedy.

  Any waiver or consent Kaan's provides must be in writing and signed by a director, attorney or authorised senior executive of Kaan's and will be effective only in the specific instance and for the specific purpose for which it is given.

SEVERABILITY

If part of the Terms of Trade is deemed to be invalid, illegal or unenforceable, the remaining provisions will remain in full force and effect.

CANCELLATION

16.1 Kaan's reserves the right to cancel any Contract with the Client, without prejudice to any rights which may have accrued up to the date of cancellation, if:

(a) the Client being a body corporate goes into liquidation, receivership or voluntary administration; or

- (b) being a person becomes bankrupt; and/or (c) the Client breaches any term of the Terms of Trade or is in default of any Contract and fails to remedy the breach or default within 7 days of receiving notice from Kaan's of the breach or default.
- If the Client cancels delivery of Goods the Client shall be liable for any loss incurred by Kaan's (including, but not limited to, any loss of profits) up to the time of cancellation.
- Cancellation of orders for Goods made or prepared to the Client's specifications will definitely not be accepted, once production has commenced.
